Adult Day Services: Three hundred and seventeen (338) seniors enrolled in the adult day care program received opportunities for socialization, recreation, mental stimulation, companionship and nutrition which improved their quality of life. In FY 16-17, the 317 seniors received 17,445 days of socialization, recreation, mental stimulation, companionship and 34,890 nutritious meals to improve their quality of life by removing them from isolation and by program design increased opportunity for interaction with peers, staff and community volunteers.); 100% of caregivers of senior clients will receive respite and supportive services which will help them care for their senior loved one in an appropriate and economically-feasible manner while maintaining them at home; and 85% of seniors will avoid long-term institutionalization. (Exceeded-Annual Caregiver Surveys revealed that 95.24% of enrolled participants avoided placement.
